

Minutes of the Molescroft Parish Council Meeting held at 7:00 pm, Thursday 17th November 2022, at the Molescroft Pavilion.

2580. Apologies

Apologies were received from Councillors Fewster, Yates, Burrows, and Pinder.

2581. Declarations of Interest

No declarations of interest were made.

2582. Approval of the minutes of the previous meeting

The minutes of the 20th October 2022 meeting had been circulated and were approved as a true record of proceedings.

2583. Planning Consultation for 22/03331/CM Land North West of Ings Road Picnic Site Ings Road, Molescroft, HU17 7LU

The Chairman read out and explained the previously circulated (10th November 2022) statement and draft minute regarding the above-named planning application. Discussion followed that also included the two members of the public in attendance, and amendments were made. The following statement was agreed upon unanimously – the Parish Council will object to the application on the grounds of traffic management.

This application raises serious concerns about traffic conditions on Grange Way. There is normally congestion at the Swinemoor Lane/Norwood junction, not only at peak times but during the day, causing backing up westwards on Grange Way. Traffic to the coast during the holiday season causes more congestion and as housing increases north of the southern bypass this extra traffic will increase congestion even more. Woodhall Way and Molescroft Road are also busier if Grange Way is congested and residents on Lockwood Road could face increased difficulty to exit the estate.

The need for a traffic management plan for Beverley, promised when the southern bypass usage could be established, is now becoming urgent. Measures to improve the Swinemoor Lane situation is surely a priority as better movement around the town is essential.

Although visibility is good in both directions at the Ings Road junction, right turns are problematical and this may cause drivers to turn left and make a turn at the nearest junction to Lockwood Road.

This Parish Council supports the provision of a new recycling facility to replace the Weel site but is not convinced that the access to this site is suitable. The traffic information does not consider the

wider continuing and progressive traffic levels impacting on the site and these factors have not been given sufficient weight in the traffic analysis.

There are also relevant material planning considerations raised by objectors commenting on the extension into the open countryside, amenity considerations and non-compliance with the local plan.

The Parish Council consider that there are substantial traffic concerns both now and for the future, sufficient to lead to the conclusion that the application should be refused.

2584. Matters Arising (All)

There were no matters arising from the previous minutes not already covered elsewhere in the agenda.

2585. Action Log (All)

The action log for November 2022 was presented with updates; work continues in the remaining areas. Cllr Hildyard is looking into possibilities for signage on the Pavilion.

2586. Update from Ward Councillor

There was no Ward Councillor in attendance.

2587. Correspondence Received/Actioned (Clerk)

The Clerk presented a range of correspondence items received since the last Parish Council meeting. These items were for information, action, consultation and response. The Clerk advised that where possible responses had been provided to the agencies/people in question. A discussion took place in relation to the items of key correspondence received and direction given by Council. The following items were discussed:

- Further emails received from residents regarding the planning application for a recycling centre on Ings Road. All residents were responded to appropriately and all comments were passed onto Ward Councillors as well as Parish Council members.
- Confirmation received from ERYC of extension of date for comments for the above planning application.
- Query regarding the state of the fencing around the playing field on Lockwood Road advised responsibility of ERYC and contact details passed on.

2588. Payment of Accounts (Clerk)

The Clerk updated the Council regarding current payments for November 2022. Payments made for November 2022 were £6,938.07. The following payments were noted:

The accounts were agreed for payment and the Chairman and Clerk (Responsible Financial Officer) signed the payment schedule as a correct record.

2589. Planning Applications (Clerk)

The Clerk advised that all planning applications received had been shared with Councillors for comment. All comments received had been submitted to ERYC within the required timescales.

2593. January Jolly (Cllr Aird)

Cllr Aird provided an update on the New Year afternoon tea event. Entertainment has been booked and posters printed.

2594. Special Expenses (Cllr Hildyard)

Cllr Hildyard advised that he and the Clerk met with Paul Palmer from ERYC to discuss the Special Expenses Plan for Molescroft. The survey plan of maintenance sites was reviewed, updated, and will be revised as an accurate record of the areas involved.

2595. Feedback from meetings attended (All)

Councillor Fleming asked the Clerk for an update on the application for commuted sums to fund new play equipment at the Pavilion. The Clerk had nothing to report and is awaiting the result of the application, which was due to be reviewed on 27th October. Clerk to contact the commuted sums team to request an update.

Cllr Fleming updated regarding the Beverley Area Community Trust, that is planning to install charity clothing banks in the area. The trust is progressing with the opening of a bank account, and has three sites ready in Molescroft, and three in Woodmansey. It is hoped that the clothing banks will be in place in the near future.
