1463. Thurlow Avenue Playing Field

The planning application for the site was considered discussed and it was agreed that this application be opposed on the grounds of: potential parking and traffic volume problems, existing flooding problems, potential future drainage problems, loss of amenity to nearby residents, public safety concerns adjacent to the existing rail line and unsatisfactory design issues. (Votes: 7 in favour, 1 against , 2 abstentions)
