Please see below planning applications received since the last Parish Council update:

10 Sheldrake Way	Erection of single storey extension to side and rear and two storey extension to the rear.	12 th March 2021	The Parish Council is concerned about the large extension which extends over the access to the rear, and is tight on the boundary. The only access to the bins, which are on the front elevation permanently, is via the front door. The side elevation is close to the neighbour, but the neighbour's extension has already reduced the access path to less than the usual one metre.
65 Curlew Close	Proposed erection of a single storey extension to the side.	12 th March 2021	No objections.
3 Longcroft Park	Re-configuration of dwelling consisting of erection of two storey and first floor extensions to sides and single storey extension to rear, re-positioning and installation of new windows and doors, application of render to rear and part render to side elevations, part timber cladding to side elevation (East) and installation of solar panels and air source heat pump following demolition of existing conservatory.	24 th March 2021	No objections.

6 Old College Drive TPO	Crown reduce 1 no. Black Pine tree by removing 1 no. limb to clear the wall and driveway due to excessive pigeon defecation as the limb has become a favoured roost with faeces damaging vehicle paintwork and is a slipping hazard on the driveway.	1 st April 2021	No objections.
