The Play equipment quotes/designs should be furthered as soon as possible and a WREN grant application should be submitted even though the final scheme may not yet be settled. Consultations with ERYC should be furthered. The designs should be displayed at the school to ascertain comments of younger persons.

109 BEVERLEY TOWN MATTERS

The Chairman reported on the recent meetings. It was agreed that the Council must be involved in the scheme as protection for future involvement in major matters affecting the Parish. It was noted that from an estimated cost of £70,000 it was hoped to secure grants and contributions of £50/60,000 **it was resolved** to make funds available for the proposed Development Plan project not to exceed £10,000.00 over a two year period.
